Capital Planning - Glossary of Terms

Attendance Area Reviews

The process of studying defined school attendance areas, for the purpose of achieving adequate and balanced accommodation amongst two or more schools.

Critical FCI rating

A school facility has a critical FCI rating when the cost of renewing the building is between 30 to 65% of the cost of replacing the existing building.

Early Learning Program (ELP)

ELP will include a full school day of learning for four- and five-year-olds and a fee based extended day for those same children. A blended staffing model comprised of one teacher and one Early Childhood Educator (ECE), working side by side, will deliver the program during the school day with an average class size of 26 students. The before- and after-school programs will be led by ECE staff and funded by parent fees set on a full cost recovery basis. The program will be expanded in stages and the goal is to have it fully implemented by 2015-16.

Facility Condition Index (FCI)

Facility Condition Index refers to the percentage of renewal funding required to upgrade/repair a school compared to the school's replacement value.

Good Places to Learn (GPL)

In February 2005, the Ministry of Education announced a new initiative called Good Places to Learn. The Good Places to Learn document cites the need for boards to provide a new, comprehensive outlook on school facilities, their conditions in the future, and their ability to provide safe environments for current program and curriculum delivery. The Good Places to Learn Grant was put into place for high and urgent component replacement needs.

Greenfield

Undeveloped land which is generally semi-rural and previously or currently being used for agricultural purposes. Greenfield lands are typically areas that are being considered for expanding urban development.

Growth School

School needed in an area of new residential development where an EDC by-law is in place. Funding for a "growth school" may be available if a business case is accepted by the Ministry of Education.

Infill

The creation of residential lots through land severances.

Capital Planning - Glossary of Terms

Learning Environment

Refers to the condition of educational spaces as they relate to the effectiveness of teaching spaces for program delivery.

On-the-Ground Capacity (OTG)

The capacity of the school as determined by the Ministry of Education by loading all instructional spaces within the facility to current Ministry standards for class size requirements and room areas.

Planning Review Areas (PE & PS)

The areas as delineated in the background study used in the preparation of the Board's Education Developmental Charge By-law.

Primary Class Size (PCS)

A province wide initiative to reduce primary class sizes. Boards must have 90% of their primary classes at 20 pupils or fewer. No primary or combined grade 3-4 class can exceed 23 pupils.

Prohibitive to Repair (PTR)

A school facility is deemed "Prohibitive to Repair" when the cost of renewing the building surpasses 65% of the cost of replacing the existing building (FCI>65%).

Pupil Accommodation Review

The review of two or more schools in order to develop viable and practical solutions for the accommodation of students within an accommodation review area. Reviews are to take place in accordance with Policy 2313, Pupil Accommodation Review.

Secondary Plans

Secondary Plans are long range municipal planning documents which direct major infrastructure: arterial roads, servicing, schools, and community parks.

Introduction to the Capital Plan

In February 2005, the Minister of Education announced the "Good Places to Learn: Renewing Ontario's Schools" document. The primary focus of this document was to implement class size caps, increase child care spaces, review accessibility, provide funding for major school repairs, replacement, growth school, and provide a framework for school closure and consolidation.

Capital Planning is a ten year rolling endeavor. Staff will continue to monitor each planning area as well as proposing study areas based upon the above and different Ministry initiatives which may alleviate certain "pressure points", or perhaps create new ones. Staff recommend to the Board of Trustees which study areas should be acted upon annually, with options presented back to the Board of Trustees for a decision. Study areas are based upon three distinct criteria: condition of school facilities, program delivery, and accommodation issues. These criteria must be recognized for the delivery of quality learning environments to the current and future students of Simcoe County.

2007 Capital Plan:

The Capital Plan recommended that five accommodation review committees be undertaken and two attendance area reviews. The Board approved these recommendations.

ARC A - Orillia DCVI, Park Street C I and Twin Lakes SS

ARC B - Collingwood CI, Elmvale DHS, Midland SS, Penetanguishene SS and Stayner CI

ARC C - Andrew Hunter ES, Hillcrest (Barrie) PS, Portage View PS, Prince of Wales PS and Warnica PS

ARC D - Alliston Union PS, Cookstown Central PS, Tecumseth Beeton PS, Tecumseth North PS

ARC E - Byng PS, Clearview Meadows ES, Duntroon Central PS, Nottawa Central PS and Nottawasaga/Creemore PS Attendance Review - Bradford ES, Fred C. Cook ES, Fieldcrest ES, Sir William Osler PS and W.H. Day ES Attendance Review - Codrington PS, Cundles Heights PS, Johnson St. PS, Maple Grove PS, Oakley Park PS, Steel St. PS, and Terry Fox ES

Four accommodation reviews and both attendance area reviews have been completed. Accommodation Review "E" is underway.

Introduction to the Capital Plan - New Initiatives

2008 Capital Plan:

The Ministry announced a new capital funding process to school boards. A Capital Priorities template was to be completed identifying priority projects that were required up to and including the 2011-2012 school year. Only permanent construction projects were identified as priority projects. Ministry funding was reviewed and allocated on a project by project approval basis at the designated ministry benchmark costs for growth, prohibitive to repair, and other, which included: localized accommodation pressure, consolidation, program enhancements, and facility retrofit. Seven priority projects were submitted to the Ministry on October 31, 2008 with supporting business cases:

Barrie Central CI - Replacement School

Painswick South PS - Growth School

Angus Morrison ES - Consolidation with Frederick Campbell E.S.

Fred C. Cook ES - Replacement School as well as consolidation with Bradford E.S.

Bradford SW PS - Growth School

Ardtrea/Cumberland Beach ES - Replacement as well as a consolidation of the two schools

Baxter Central PS - Septic Replacement which was to supplement the PTR funding of the Annex.

The Ministry approved the Angus Morrison E.S. capital priority project and did not approve the remaining projects.

In addition to the priority capital projects, the Board approved, two elementary and one secondary attendance area review.

Attendance Review: Assikinack PS, Ferndale Woods ES, Trillium Woods ES and new Ardagh North ES

Attendance Review: Admiral Collingwood ES, Cameron St. PS, Connaught PS, Mountain View ES, Nottawa C. ES and Worsley PS

Attendance Review: Bradford D.H.S. and Nantry Shores S.S.

Early Learning Program:

In 2008, the Ministry announced some funding for Full Day Learning for Four and Five Year Olds. In light of this announcement the concept of including all day learning into the system for 2010 was included in the Capital Plan analysis. The Ministry has officially announced the implementation of Early Learning Program (ELP). The ELP will begin implementation in 2010, and will take five years to implement. The Ministry has not announced further capital funding for the implementation. The first two years of ELP will be placed in schools that can accommodate the ELP without the need for capital improvements. The Ministry has approved 31 classrooms for phase one (Sept 2010) of early learning implementation, and 14 classrooms for phase two (Sept 2011). The Ministry will consult with the Board regarding future capital needs to implement years 3, 4 and 5. The board will be recommending 16 elementary schools to be implemented in year one of the ELP, however, the board is required to submit a total of 62 eligible spaces for the Early Learning Program. In January 2010, the Ministry will announce which schools will receive the ELP.

Introduction to the Capital Plan - New Initiatives

On The Ground (OTG) Capacity Changes:

As a result of the ELP announcement, the number of students to be accommodated in kindergarten spaces will increase from 20 students to 26. This change in OTG capacity will increase capacity of each school. Although the capacity will be greater, more students need to be accommodated as a result of kindergarten students attending school everyday. Full analysis of the impact in capacity changes versus the students to be accommodated still needs to be completed. Once the impact is identified, the Capital Plan will be updated.

Encouraging Facility Partnerships:

Facility Partnerships is a new ministry initiative to encourage sharing of facilities with community partners which will benefit the board, students and the community. Partnerships are to be explored by the board when constructing new schools, undertaking significant renovations and the use of unoccupied space. The Board is required to implement this initiative through policy, which may impact the Capital Plan. If there is an impact on the Capital Plan, changes will be included as required on an on going basis.

Facility Condition Index (FCI):

In 2005 the Ministry announced the Good Places To Learn (GPL) initiative. Funding allocation was based upon a list of component replacement and repairs based upon their life cycle. The data was collected by a third party consulting firm hired by the Ministry of Education. This data was entered into a database named ReCAPP. ReCAPP data became the benchmark data set to analysis when components had reached a level of high or urgent, resulting in GPL funding. Board staff maintain the ReCAPP database by entering in jobs which have been completed. In addition to updating the component portion of the dataset, the board has designed a three year rotation cycle to evaluate the conditions of the components for each and every school. The north area data collection has just been completed, and entered into ReCAPP. For the purposes of the Capital Plan, board staff use this updated system to flag buildings which may be inadequate to meet the current and future needs of students.

Simcoe County Growth

Simcoe County is comprised of 16 municipalities and two separated cities, with a population of 439,500 people. The County's growth management strategy projects the area to grow to 667,000 people by 2031, an increase of 130,000. The growth strategy assumes growth will continue at a rate of approximately 4,000 residential units a year, primarily comprised of single and semi-detached units. The strategy suggests that the main change to residential development in the next 25 years will be an increase in density. The provincial government issued a document entitled "Simcoe Area: A Strategic Vision for Growth". The document directs growth to five urban nodes: Alliston, Barrie, Bradford, Collingwood, and Orillia. At this point in time, the provincial growth plan and that of the County of Simcoe's growth plan differ. The County is undergoing changes to meet Provincial targets. The allocation of future growth is summarized in the following table:




Capital Planning - Secondary Planning Review Area


Secondary Review Area - Simcoe County, Barrie, Orillia - Present Situation


ORILLIA DEVELOPMENTS
